


The Resource person Dr. A. FougियाBegam delivered the chief guest address and offers some basic self-defense tactics.

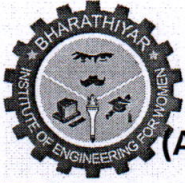


Anybody indulging in "Ragging" will be severely punished.


The punishment includes suspension/dismissal from the roles of the institute apart from prosecuting the indulgent with criminal charges.
